INDIAN STAMP (COLLECTION OF STAMP DUTY THROUGH STOCK EXCHANGES, CLEARING CORPORATIONS AND DEPOSITORIES) RULES, 2019

DPs are advised to refer communique number CDSL/OPS/DP/POLCY/2019/643 dated December 24, 2019 regarding the Central Government notification dated December 10, 2019 pertaining to the Indian Stamp (Collection of stamp-duty through Stock Exchanges, Clearing Corporations and Depositories) Rules, 2019 to regulate the liability of instruments of transaction in stock exchanges and depositories to duty. The said rules was to come into force on **Thursday, January 09, 2020.**

DPs are now advised to note that the Central Government Notification dated January 08, 2020 has postponed the said enforcement and the rule will come into force on **Wednesday, April 01, 2020** (copy of notification is enclosed as "**Annexure**").

DPs are advised to take note of the same and inform their clients accordingly.

- (2) भारतीय स्टाम्प (स्टॉक एक्सचेंज, समाशोधन निगमों एवं निक्षेपागारों के माध्यम से स्टाम्प शुल्क का संग्रहण) नियम, 2019 में, नियम (1) के, उप नियम (2) में, "9 जनवरी 2020" शब्दों और अंकों के स्थान पर "1 अप्रैल 2020" शब्द, अंक और अक्षर रखे जाएंगे।

NOTIFICATION

New Delhi, the 8th January, 2020

- **G.S.R. 19(E).**—In exercise of the powers conferred by section 73A of the Indian Stamp Act, 1899 (2 of 1899), the Central Government hereby makes the following rules to amend the Indian Stamp (Collection of Stamp-Duty through Stock Exchanges, Clearing Corporations and Depositories) Rules, 2019, namely:—
- (1) (1) These rules may be called as the Indian Stamp (Collection of Stamp-Duty through Stock Exchanges, Clearing Corporations and Depositories) (Amendment) Rules, 2020.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- (2) In the Indian Stamp (Collection of Stamp-Duty through Stock Exchanges, Clearing Corporations and Depositories) Rules, 2019, in rule (1), in sub-rule (2), for the words and figures "9 day of January 2020" the words, figures and letters "1st day of April 2020" shall be substituted.
